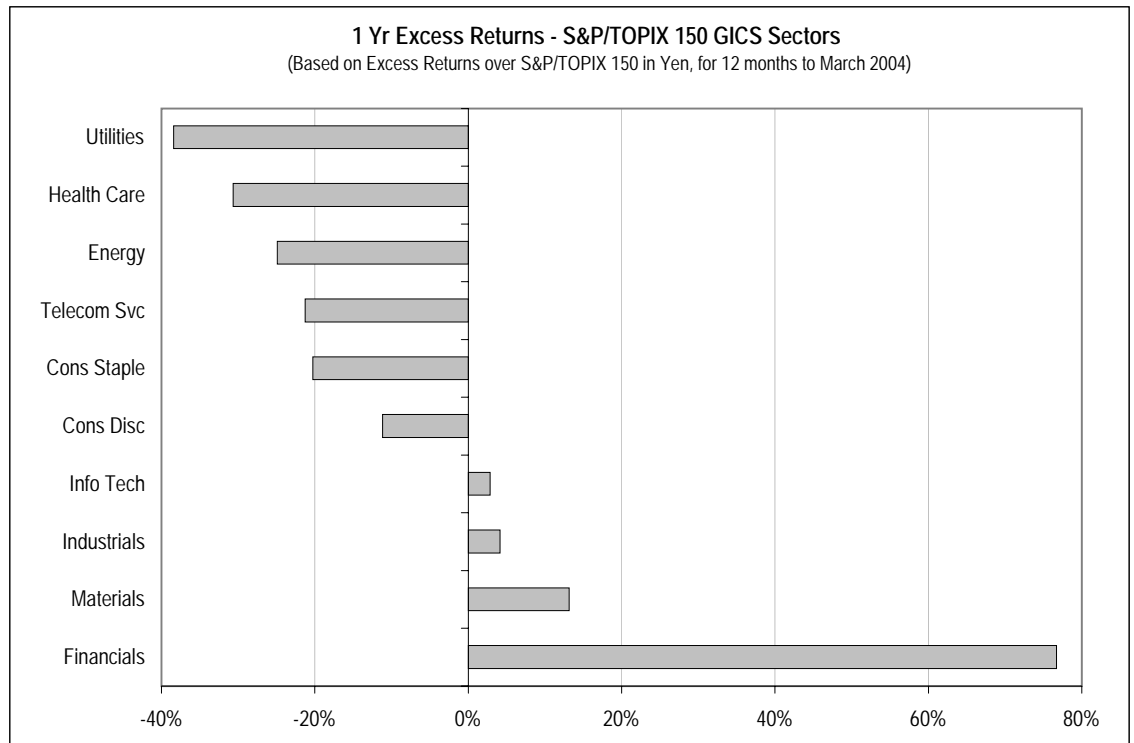

Quarterly Excess Returns Relative to S&P/TOPIX 150

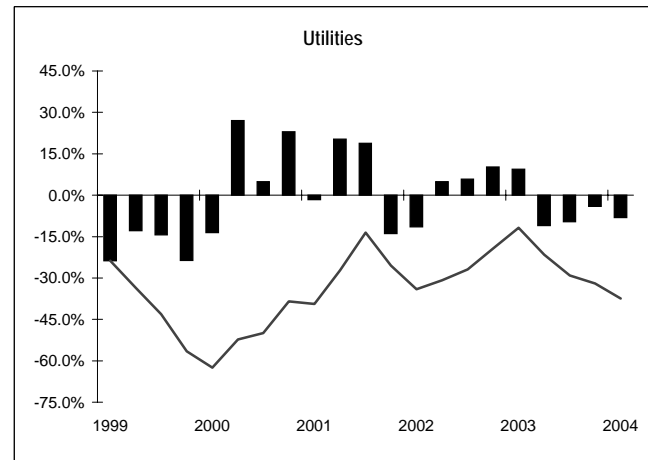
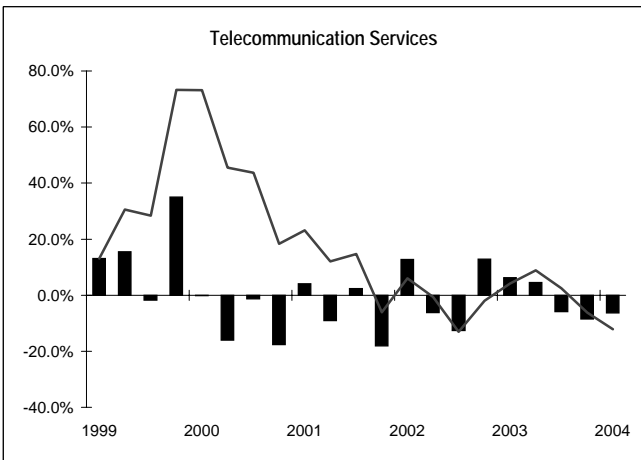
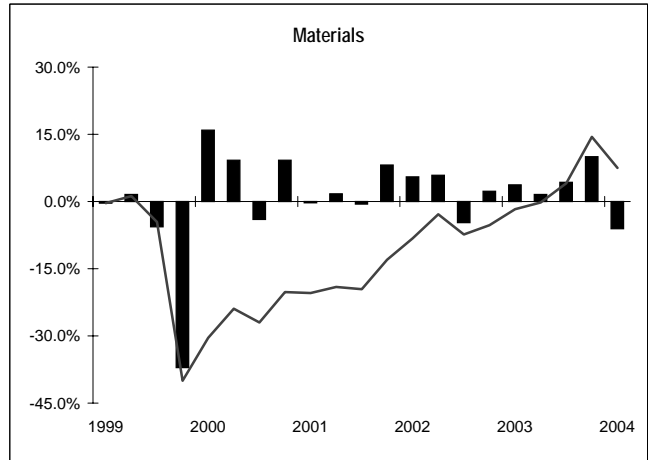
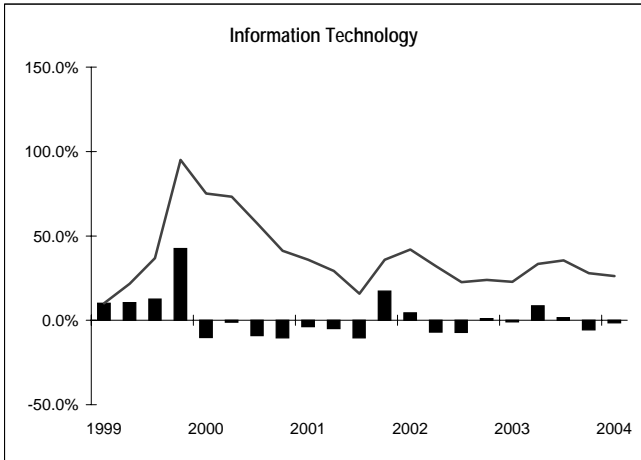

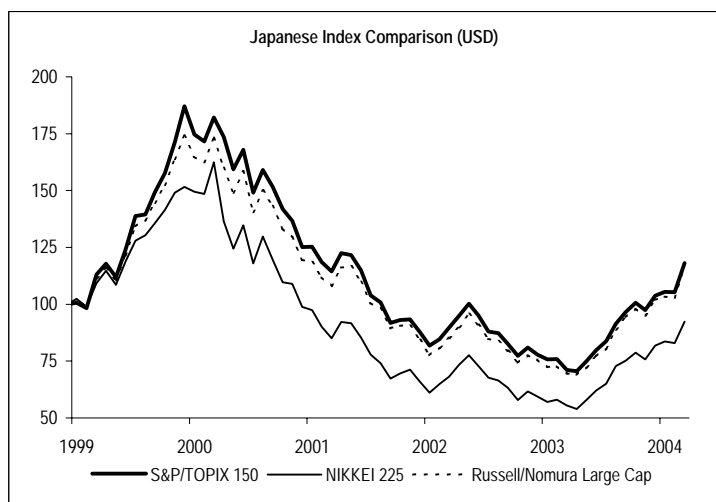
